Spread of COVID-19 Coronavirus in the Academy	Staff, pupils, parents / carers and visitors	<p>The Academy will follow the government advice on <u>SEND and specialist settings: additional COVID-19 Operational Guidance</u> where reasonably practicable</p> <ul style="list-style-type: none"> • Minimise contact with individuals who are unwell by regular contact with parents and staff; identify those who have coronavirus (COVID-19 / cold / flu symptoms and advise them not to attend school • Ensure that pupils, staff and other adults do not come into the school if they have <u>coronavirus (COVID-19) symptoms</u>, or have tested positive in the last 10 days. • If anyone in the school becomes unwell with a new and persistent cough or a high temperature, or has a loss of or change in, their normal sense of taste or smell (anosmia), they must be sent home and advised to follow <u>guidance for households with possible or confirmed coronavirus (COVID-19) infection</u>, or positive home Lateral Flow Test, which sets out that they should self-isolate for at least 10 days and should <u>arrange to have a PCR test</u> to see if they have Covid-19. • Any child awaiting collection, will be moved to the Welfare Officer's room (BHC) with external ventilation (open window) where they can be isolated behind a closed door, depending on the age and needs of the child, with appropriate adult supervision if required. A separate toilet for them to use is the located near old Welfare Officer's room (BHC). The toilet will be cleaned using standard disinfectant before use by anyone else.
